NOTE TO THE SUMMARY FINANCIAL ACCOUNTS

This year the Trustees have had the accounts financially examined as the annual turnover is under £250,000.

Park Farm Costs include salaries, rent and rates, utilities, office and general expenses, professional fees, maintenance and bank charges.

TREASURER'S REPORT

Following the Centenary year of the National Federation of WI's and our own 95th anniversary last year we have settled back to a more normal year albeit still busy and inspiring. The profit and loss accounts show a deficit of £10,385.67 but, due to the good performance of our investments and the dividends received which totalled £12,578.00, our overall capital has increased. In view of this the board have re-invested the dividends accrued over the year from our portfolio with Barratt and Cooke.

We must remember that stocks and shares can go down as well as up. Our investments through Barratt & Cooke, a stockbrokers experienced in working with charities, was, at the time of closing our accounts, showing a substantial and pleasing profit and their annual report is very positive.

In comparison to previous years, the Park Farm income appears to have dropped by around £10,000. This is due to the change in our investments from accounts which paid interest either monthly, quarterly or annually which showed as income whereas the dividends show in the revaluation of our stocks and shares.

The Board are looking into events such as a show at the Apex which would be open to the public and raised funds from a wider audience rather than just WI members.

Looking to the future, running the Park Farm office is costly and the rent has increased this year by 19%, following the renewal of the lease, our first rise since moving to Park Farm 10 years ago so fund raising is a big issue and your continued support is appreciated.
