

## **Resolution timetable 2021/22**

*This timetable provides all of the major dates and deadlines for the 2021/22 resolutions process. Please use this to plan your meetings within your federation or WI. The timetable states when information will be released in *WI Life* or through the mailing to all WIs and federations. In addition, information will regularly be added to the main NFWI website ([www.thewi.org.uk/campaigns/resolutions](http://www.thewi.org.uk/campaigns/resolutions)) and *My WI* ([mywi.thewi.org.uk](http://mywi.thewi.org.uk)).*

10 September 2021	Closing date for resolutions to be submitted to the NFWI. The federation deadline is earlier (please check with your federation).
24 September 2021	Resolutions longlist circulated to federation representatives and member delegates attending the shortlisting meeting on 5 October.
5 October 2021	Federation representatives and member delegates meet virtually to compile a shortlist of resolutions, supported by NFWI trustees and staff.
2 November 2021	Shortlisted resolution resources, including videos and PowerPoint presentations, published on the NFWI website and My WI.
19 November 2021 <i>WI Life</i>	Shortlisted resolutions, essential facts and points, and selection slip appear in the November issue of <i>WI Life</i> .
Late November 2021 – early February 2022	Members consider the shortlisted resolutions and meet as federations and WIs to discuss and learn more about the issues. Members select the resolution they support the most.
14 February 2022	Deadline for members’ resolution selection slips to arrive with federations.
21 February 2022	Deadline for federations to return tallied selection results to the NFWI.
Late February 2022	The NFWI Board of Trustees finalises the resolution/s for the 2022 Annual Meeting based on the number of selections from WI members. A memo is sent to federations confirming the outcome in order to cascade this information to WIs. The resolution/s is also announced on the NFWI website.

March 2022 <i>Mailing</i>	Annual Meeting resolution/s briefings and wording sent to federations, WIs and WI Advisers.
April 2022 <i>WILife</i>	Annual Meeting resolution/s wording and notes published in <i>WILife</i> .
April & May 2022	Federations and WIs hold meetings to discuss the Annual Meeting resolution/s. WIs vote for or against one or more resolutions, or give their delegates discretion*.
2 May 2022	Deadline for resolution amendments and urgency resolutions to be submitted to NFWI.
11 June 2022 <i>Annual Meeting</i>	Debate and vote on resolution/s held at the Annual Meeting.
July 2022 <i>Mailing</i>	Result of the vote on the 2022 Annual Meeting resolution/s is included in the July mailing.
July/August 2022 <i>WILife</i>	The 2022 Annual Meeting resolution/s are published in the July/August issue of <i>WILife</i> .

\*WIs can give their delegate discretion to vote as they wish after hearing the speakers for and against the resolution.
